I. COMPANY PROFILE

IRCTC was incorporated in 1999 under the Indian Companies Act, 1956 with the objective of strengthening Railway's marketing and service capabilities in the areas of rail catering, tourism and passenger amenities. IRCTC is a Schedule 'B' Mini Ratna CPSE under the administrative of control M/o Railways.

Its Registered and Corporate offices are at New Delhi

The authorised and paid-up capital of the Company were Rs.50 crore and Rs.40 crore respectively as on 31st March, 2017.

The shareholding by the Government of India is 100%.

II. JOB DESCRIPTION AND RESPONSIBILITIES

Director(Finance) is a member of Board of Directors and reports to Chairman and Managing Director. He/She is overall incharge of finance and accounts of the organization and is responsible for evolving and formulating policies relating to finance and accounts as well as implementation thereof.

III. ELIGIBILITY
