

Indian Railway Catering and Tourism Corporation Ltd. (IRCTC) is a "Mini Ratna (Category-I)" Central Public Sector Enterprise under Ministry of Railways, Government of India. IRCTC was incorporated on 27th September, 1999 as an extended arm of the Indian Railways to upgrade, professionalize and manage the catering and hospitality services at stations, on trains and other locations and to promote domestic and international tourism through development of budget hotels, special tour packages, information & commercial publicity and global reservation systems.

2. IRCTC requires experienced and result oriented retired employees for need-based engagement for **Railway Station /Field Offices** (Operation and Commercial) under **South Zone/Chennai** on re-engagement basis for a total vacancy of 6 (Six) (number of vacancy) one each at **ERS, UBL, TVC, TEN, MYS & NCJ**. To meet the immediate requirement of manpower, the Company invites applications **from Retired Officials**, to form need based panel through selection procedure.

3. The deployment of the selected retired employee through the said selection procedure will be made as per administrative requirement/need basis for posting in IRCTC in its various offices. The empanelment of Retired employees will be as per the eligibility criteria laid down in HR policy and as revised/amended from time to time, based on the Level/pay-scale (7th CPC/3rd PRC) from which the employee has retired. The eligibility of the retired employees who can apply for re-engagement is mentioned as under: -

4. Further details are as under:

I. **Duration:** Initially for One (01) year or till the completion of the project, whichever is earlier. The tenure can be extended as per the requirements/performance of the retired officer and at the sole discretion of IRCTC. Re-engagement as Consultant can be terminated pre-maturely on one month's notice by either side, However, IRCTC can cancel the appointment at any time without providing any reason for it.

II. **Remuneration & Scope of Work:** As per extant policy of IRCTC. Monitoring of the movement of Trains, Coordination with the Indian Railways along with State Govt. and looking after all the Catering, Railneer and Tourism activities (including onboard services) at the respective Stations or as decided by the Controlling office

III. **Selection/Interview:** The selection will be done at zonal office/Chennai through interview/Interaction for which date and time will be intimated to the applicants separately.

IV. **Submission of Application:** The applicant is required to submit his application at zonal office or through the respective e-mail address latest by 04.09.2025 by 17.00hrs in the prescribed format along with other requisite documents i.e. PPO/Service Certificate and copy of Aadhar Card etc.



V. **Leave:** Reengaged Consultant will be granted 1.5 days leave for each completed month of service in IRCTC and such leave shall not have any specific nomenclature like CL, Earned Leave etc. The accumulated leave cannot be carried forward to the next calendar year.

VI. **Selection Process:** Through the process of calling of applications from the eligible retired personnel for forming a panel against the above-mentioned post on re-engagement basis on the basis of interview, for which date and location will be intimated separately.

VII. Those candidates suffering from COVID-19 or COVID-19 like symptoms, will not be allowed for interview.

VIII. **Medical Examination:** The selected will have to undergo medical examination /health check-up and will be considered for re-engagement only if they are found medically fit, in addition to fulfilling other criteria.

XI. How to Apply:

- (i) Retired employees from Indian Railways fulfilling the eligibility criteria laid down above, should send duly filled in prescribed proforma enclosing therewith self-attested photocopies of the requisite documents i.e. PPO (as per 7th CPC), Service certificate, Last Pay slip, Aadhar card, etc.
- (ii) The retired employees shall have to produce original Service Certificate, PPO and other documents for verification in original at the time of interview. The candidates will not be allowed for interview, if they don't bring the documents on the date of interview. If any of the particulars stated by the retired Railway employee is found that he has wilfully suppressed any material fact/information relevant to the consideration of his/her case without prejudice to any other action that may be taken in concurrence thereof his/her candidature will be summarily rejected and will not be interviewed.
- (iii) In addition, the proof of identity and residence, last pay slip and two recent passport size photographs and documents as mentioned in the application Format and working experience on the proforma will be required.
- (iv) Duly filled in application, along with documents, should be sent at following address to reach on or before 04/09/2025.

- (iv) The retired employees who had earlier worked in IRCTC in any capacity but terminated from service for any reason or extension of re-engagement not granted will not be considered for interview.

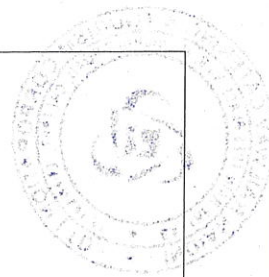

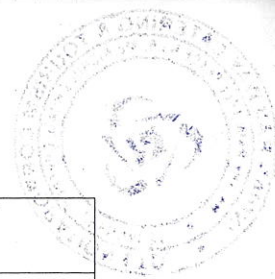

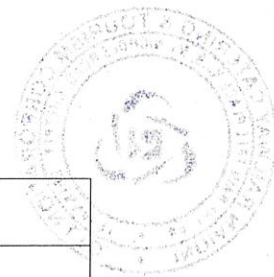
