5. If Railway suggests changes in the General Arrangement of Drawing (GAD), the new GAD has to be submitted by you within 15 days of the issue of letter.
6. You are required to take over the site within 07 days of the issue of letter of approval of GAD from IRCTC at the same time you are also required to deposit 50% of the licensee fee agreed upon.
7. You are also required to execute agreement within 30 days after commissioning of the unit on non judicial stamp paper of Rs. 100/- as per the tender conditions.
