4. To submit preliminary plans, specifications and tentative time schedule for commissioning of above unit for approval of IRCTC East Zone within 15 days from the date of remittance of security deposit.
5. If Railway suggests changes in the General Arrangement of Drawing (GAD), the new GAD has to be submitted by you within 15 days of the issue of letter.
6. You are required to take over the site within 07 days of the issue of letter of approval of GAD from IRCTC at the same time you are also required to deposit 50% of the licensee fee (plus all applicable Taxes) agreed upon.
7. You are also required to execute agreement within 30 days after commissioning of the unit on non-judicial stamp paper of Rs. 100/- as per the tender conditions.

In the event of failure to adhere above instructions same will be treated as event of default and action will be initiated as per terms and conditions of the license.
