Sub: Compliance of various provisions of the Labour Laws - Contribution towards the ESIC.

The Regional Office, Employees' State Insurance Corporation/New Delhi, recently, carried out an investigation to assess payable ESI contribution for the period from 2012-13 & 2013-14, in respect of Employees of IRCTC and other expenditures incurred for maintenance, development, repairs, security services, pantry services for operation & management of the Corporation, fixed liability of IRCTC towards ESI contribution in respect of aforesaid heads. Accordingly, the matter was pursued at ESIC/RO/New Delhi, based on the available documents/records as provided by the concerned departments; but, we could not avoid the liabilities of Rs.4,24,795/- towards the ESI for want of documents maintained by respective departments.

Beside above, the instructions contained in Railway Board's letter No.2018/CE-I/CT/4 dated 17.10.2018 (re-circulated vide CO/HRD's letter No.2019/IRCTCHRD/Rly_Bd_Instruction dt.31.03.2021) for updating the details of workmen and the payments made towards the minimum wages, PF, ESI, etc. on Railway's *Shramikkalyan portal* by the Contractors/service providers should also be ensured. Documents invariably; and the Labour law compliances should be ensured before processing the bills for payment to the Contractors.

It is requested that all efforts should be made to ensure submission of the contribution towards ESI/PF, in addition to other compliances under various labour laws viz. Payment of Wages Act, Contract Labour (R&A) Act, Minimum Wages Act, etc. This issues with the approval of the Competent Authority.
