SCOPE OF WORK

- 1. Regular inspection and monitoring of the premises for pest activity.
- 2. The Pest Control service will include: -

Service	Pest Covered
Integrated Ant Management Service	Ants: Little Black Ant, Pharaoh Ant, Crazy Ant, Carpenter Ant, Ghost Ant
Gold Seal Service	Cockroaches: German, American & Brown Banded
Pied Piper Service	Commensal Rodents: House Mouse, Roof Rat, Norvegicus Rat, Lesser Bandicoot Rat & Greater Bandicoot Rat
Fly Management Solutions	Filth Flies: House Flies, Flesh Flies, Blow Flies, Fruit Flies, Drain Flies, Phorid Flies
Integrated Lizard Management	House Lizards
Spider Treatment	Cobweb Spiders & Jumping Spiders

- Use of Baiting, Trapping & proofing methods with selective use of chemicals/pesticides wherever necessary.
- Use of Glue Boards/Traps etc. as a part of rodent pest management operations wherever necessary.
- The items/products/chemicals used shall be safe/unharmful to human and food product contacts.
- Agency shall be also be responsible for Storage Pest Management.
- Periodic sanitization of storage area, packaging are cooking are and loading area.
- **3.** Effective periodicity for providing pest control services-Fortnightly or as required.
- 4. Safe and effective treatment using environmentally friendly chemicals and methods. The Pest Control Plan shall consist of three parts as follows:
 - Proposed Materials and Equipment for Service: The Agency shall provide current labels
 and Material Safety Data Sheets for all pesticides to be used, and brand names of pesticide
 application equipment, rodent bait boxes, insect and rodent trapping devices, pest
 monitoring devices, pest detection equipment, and any other pest control devices or
 equipment that may be used to provide service.
 - **Proposed Methods for Monitoring and Detection**: The Agency shall describe methods and procedures to be used for identifying sites of pest harborage and access, and for making objective assessments of pest population levels throughout the term of the contract.
 - Description of any Structural or Operational Changes That Would Facilitate the Pest Control
 Effort: The Agency shall describe site-specific solutions for observed sources of pest food,
 water, harborage, and access. Commercial Pesticide Applicator Certificates or Licenses: The
 Contractor shall provide photocopies of State-issued.
- 5. **Record Keeping:** The agency shall be responsible for maintaining a pest control logbook through digitally module. These records shall be kept updated on real time basis and maintained on each visit by the agency.
