4. To submit preliminary plans, specifications and tentative time schedule for commissioning of above unit for approval of IRCTC with Regional /Area office within fifteen (15) days from the date of remittance of Security Deposit, along with acceptance of Terms and Conditions of the license.
5. If Railway/IRCTC suggests changes in the General Arrangement of Drawing (GAD), the new GAD has to be submitted within fifteen (15) days after advice by zonal office.
6. You are required to take over the site within time frame specified by the Zone after issuance of letter of approval of GAD. At the same time, you are required to deposit 50% of the License fees (plus all applicable taxes) as agreed upon.
7. You are also required to execute agreement on non-judicial stamp paper of Rs.100/- within 30 days' time after commissioning of the unit or the additional time as advised by IRCTC as per tender conditions.

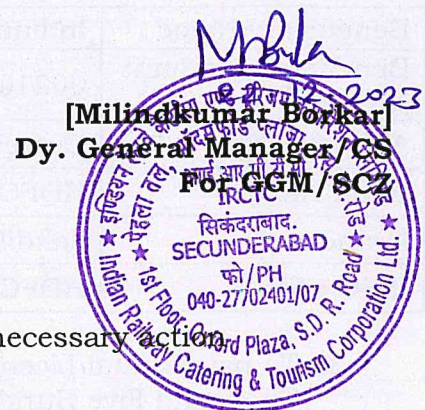
