

Vide OM under reference (i) and (ii) above, DoE (MoF), had issued guidelines to support MSMEs by providing relief in all procurements, by release of 95 % of forfeited security Deposits, forfeited EMDs, Risk purchase recoveries, deducted LD (Liquidated Damages) and revocation of debarment for non-performance in the contracts, for the period where original delivery period was between 19-02-2020 and 31-03-2022 (for SD, LD and RP recovery) and tender opened between the same period for EMD.

Vide OM under ref (iii), the requests for relief in case of General Damages was also decided to be dealt in the same manner as for relief of performance security/risk purchase.

Now, vide OM under reference (iv) above, DoE has extended the ambit of relief for MSMEs to earning contracts as well.
