4. To submit preliminary plans, specifications, inter-alia and tentative time schedule for commissioning of above unit for approval of IRCTC East Zone within 15 days from the date of remittance of security deposit.
5. If IRCTC suggests changes in the General Arrangement of Drawing (GAD), the new GAD has to be submitted by you within 15 days of issuance of the letter.
6. To take over the site within seven (07) days of the issuance of letter of approval of GAD from IRCTC. At the same time you are also required to deposit 50% of the licensee fee (plus all applicable Taxes) agreed upon.
7. To execute agreement within 30 days after commissioning of the unit on non-judicial stamp paper of Rs. 100/- as per the tender conditions.
8. To submit the GST Certificate pertaining to West Bengal in the name of your firm before commencement of the unit failing which the unit cannot be commissioned.


