With reference to your Technical Bid opened on 22.12.2022 & Financial Bid opened on 17.03.2023 for the above project, it has been decided to award you the license for Renovation, Operation, Maintenance & Transfer back of Retiring Room & Dormitory at **Araku** Railway Station for a period of (09) Nine years from the date of commissioning of the Unit on the following conditions, in addition to terms & conditions mentioned in tender document. You are therefore required:

- 1) To convey your acceptance of the award of licensee with the terms and conditions of the license on or before **27.04.2023** along with payment of Security Deposit as per the format of acceptance letter enclosed herewith as Annexure-A.
- 2) To remit an amount of **Rs. 5,500/- (Rupees Five Thousand Five Hundred Only)** towards **Security Deposit** in favor of IRCTC Ltd. payable at IRCTC/South Central Zonal office, Secunderabad through NEFT/RTGS in IRCTC account on or before **27.04.2023**.
- 3) To pay Annual License fee of **Rs.11,888/- + GST @ 18% Rs.2,140= Rs.14,028/-(Rupees Fourteen Thousand Twenty Eight only)** and all other applicable taxes as per tender conditions. Payments to be made through NEFT/RTGS in IRCTC account.
- 4) Payment of Security Deposit and Annual Licensee Fee to be made through NEFT/RTGS in IRCTC/SCZ account and Bank A/c details are as under :



- 6) If Railway/IRCTC suggests changes in the General Arrangement of Drawing (GAD), the new GAD has to be submitted within fifteen (15) days after advice by zonal office.
- 7) You are required to pay advance annual license fee and GST thereon along with land license fee with applicable taxes and other taxes if any to IRCTC in advance.
- 8) You are required to pay License fee as mentioned in the point no. 3 above, GST thereon and other tax if any to IRCTC. The quoted annual License Fee for 1st year shall be paid in advance at the time of handing over of site but is applicable from time of commissioning of Retiring room & dormitories or within 120 days from the date of issue of LOA whichever is earlier.
- 9) You are required to take over the site within time frame specified by IRCTC Zonal/ Regional office after issuance of letter of approval of GAD. At the same time you are also required to deposit Annual Licensee Fee (plus all applicable taxes) agreed upon.
- 10) License fee will be increased by 5% per year compounded annually from second year onwards. At the start of second year the license fee deposited will be 5% more than the quoted license fee for first year or 15% of the annual sales turnover for the first year, whichever is higher. Similar increase in payments of license fee will be followed for each subsequent year of service.
- 11) You are also required to execute agreement immediately after commissioning of the unit on non-judicial stamp paper of Rs.100/- as per tender conditions.
- 12) All terms and conditions of the tender document shall remain the same and form integral part of this letter of award.
- 13) This letter of award is subject to the final outcome of writ petition, if any, filed in any high Court.
- 14) The Service Provider shall comply with the directions/protocol issued by Govt. of India/IRCTC from time to time.
- 15) In the event of failure to adhere above instructions same will be treated as event of default and action will be initiated as per terms and conditions of the License.
