- 1. Validity: This contract is valid for a period of 02 (Two) years i.e. from 28.03.2025 to 27.03.2027.
- 2. <u>Delivery:</u> The supply of BOPP Self Adhesive Tapes has to be done at Rail Neer Plant, Ambernath as indented by the purchaser.
- 3. <u>Inspection:</u> As cent percent inspection is not possible or practicable at the time of supply, the contractor shall replace the material at his own cost, defective material if found afterwards on opening seals. If the same are not replaced in the reasonable time, the cost thereof will be recovered from contractors' subsequent bills.
- 4. **Specification:** The supply of BOPP Self Adhesive Tapes should be as per the specifications laid down in the Technical Specifications mentioned in the Annexure IV of tender document.

- 8. Security Deposit: 5% of the value of the contract i.e. Rs. 1,04,410/- (Rupees One Lakh Four Thousand Four Hundred Ten Only) in the form of RTGS/NEFT/Demand Draft has to be deposited within 15 days from the issuance of this Letter of Award. No interest will be payable on Security Deposit.
