Letter of Award (LOA) for meal tray branding in Train No. 82901-02 ADI-MMCT-ADI Tejas

With reference to your email under reference regarding branding of outer meal tray holders on all of Train No. 82902/01 ADI-MMCT-ADI Tejas Express for a period of 6 month at a cost of Rs. 3,85,000 + 69,300/- (GST@ 18%) has been approved by Competent Authority. The terms and condition for the same, attached as Annexure "A", is summarised below:

1. The contract period shall be for a period of 6 month.

- 2. The contract period shall begin from 01.02.2025 to 31.07.2025 or till the train is operational, whichever is earlier (excluding installation days).
- 3. The contract covers all operational coaches subject to a maximum of 14 (3 EC & 11 CC).
- 4. Rentals have been considered on 06 days per week basis and if the frequency of train is reduced, the said contract period shall be extended on a pro-rata basis.
- 5. The lease amount will have to be paid in advance within 3 days of issue of this letter.
- 6. The installation (sticking and pasting), maintenance and removal post end of contract of the stickers will be done by the licensee. IRCTC will facilitate coordination with Sr. CDO Kankariya, however the scheduling and coordination will be done by licensee.
- 7. All standards laid down by Government of India for advertisement will be adhered to and the Licensee will be responsible for any penal action under the existing laws and will indemnify IRCTC against any complaint or action as a result of such complaint.
- 8. The matter will be shared by IRCTC in advance. The guidelines of Advertising Standards Council of India (ASCI) may be followed.
