Terms & Conditions:

1. The contract will be valid for Two (02) years, starting from **25.10.2024 and expiring on 24.10.2026**. IRCTC reserves the right to extend the contract for a further period of six months on the same rates, terms and conditions.
2. 3. Railneer Samples are to be collected from the Site i.e. RailNeer Plant, Ambernath within the quoted rates.
4. For all parameters of testing of mentioned under Price schedule, latest BIS guidelines as per IS14543 (presently **BIS DOC: SIT/14543/ 6 July 2024**) **has to be followed**. Testing frequencies may be changed in future as per the requirement or as per BIS guidelines.
5. Payment shall be made only for the no of samples collected & tested against the submission of original GST invoices and test reports in duplicates.

6. In case of failure in conformity as per IS 14543:2024 in the sample, laboratory have to recheck the samples and submit both the reports. In such scenario the payment will be made only towards one testing.
7. In case of any shortcoming in service IRCTC has full rights to terminate the contract at any time.
8. Payment will be made after completion and submission of original copies of test report along with the GST tax invoice.
9. Copies of any records/reports as required by IRCTC shall be made available at any time request.
10. In case of any temporary suspension of BIS/NABL accreditation, the firm has to arrange alternative testing arrangement as per our periodicity of testing calendar at same cost, terms and conditions. Failing which Security Deposit will be forfeited.
11. Any damage during sample collection & transportation to the lab due to the carelessness on the part of firm's staff, it will be responsibility of your lab, fresh samples have to be recollected by the lab without any extra cost.
