- D) You are required to submit the list of proposed pickup locations for meal (B/F, lunch & dinner) along with its addresses for approval of IRCTC. The same should be submitted as indicated in the enclosed format for acceptance letter.
- E) If you fail to accept the offer of award of License or fails to remit license fee, within the stipulated time as advised by IRCTC, action will be taken as per terms & Conditions of tender.
- F) Supply/sale of Railneer is to be made in the train in terms of clause no. 2.11, 2.12 &2.13 of Scope of Work of the tender condition on MRP.
- G) Point of Sale machines as per clause 2.18 of tender document has to be ensured.
- II) IRCTC approved, Packed branded RTE items like poha, Upma, Veg meal, Combo meal etc. with FSSAI license and MRP, with best before date has to made available in train in addition to Cooked Food.
