- 5. To submit preliminary plans, specifications, Brand name to be displayed on the unit and tentative time schedule for commissioning above unit for approval of IRCTC / Railways, within 15 days from the date of remittance of security Deposit.
- 6. If IRCTC/Railways suggest changes in the General Arrangement of Drawing (GAD), the revised GAD has to be submitted by you within fifteen (15) days after advice by Zonal Office.
- 7. To take over the site within time frame specified by IRCTC after issuance of letter of approval of GAD. The 50% of annual License Fee plus applicable taxes, shall be payable before the handing over of the site. Remaining 50% of the Annual License fee plus applicable taxes, shall be payable before completion of six months from the date of commencement of the unit.
- 8. For the subsequent years. Annual License Fees plus applicable taxes shall be payable by the Licensee in advance on half yearly basis depending on the operational cycle. i.e. License Fee for initial 06 months of 2nd business year in advance and similarly for remaining 06 months of 2nd business year in advance.
