- 1. Scope of Work: The scope of work for water availability study shall include:
  - (i) Examining suitability of the proposed sites at Prayagraj, Bhagalpur and Ranchi with reference to available topo sheets, local revenue maps and hydro geological maps, and other documents for ground water assessment and related Government Orders available.
  - (ii) Compile site information covering Geographical, Geological, Geo technical and Hydro geological conditions to access the availability of water and projected yield for 25-30 years. The minimum requirement being 1.50 Lakh liters per day.
  - (iii) Conduct chemical quality analysis of groundwater samples as per the prevailing hydrogeology of the area.
  - (iv) To carry out hydrogeological evaluation and geophysical investigations in the selected sites in order to determine potential for groundwater at project site.
  - (v) To prepare hydrogeological survey reports in conformity with the provisions of the rules and procedure outlined by the Central Ground Water Board (CGWB), by Assessment of water quality and potential infringement of National standards, Assessment of availability of groundwater and Impact of proposed activity on aquifer, water quality and other abstractors.
- 2. Deliverables: Project report must contain the following:
  - a) Desired water availability data projection over 30 years period.
  - b) Detail recommendations for development of bore well meeting desired quality and quantity.
  - c) Raw water test report as per IS 10500 from NABL laboratory.
