**Sub:** LOA for operation of Maharashtra Mukhyamantri Teerth Darshan Yojna Trains for a period of 3 years or till the period of MOU signed between IRCTC and Government of Maharashtra is revised, to be operated on Western Railway rake.

The Competent authority has accepted the rate of Rs. 1,770/- per person per day inclusive of GST for Single Destination irrespective of the itinerary or number of days of operation with a minimum guarantee of 750 passengers for providing backend (On-board/ Off-board) services of the above subject as per the terms & conditions. The service inclusions are attached as Annexure - A.

Further, the rates will be valid for a period of 3 years or till the period of MOU signed between IRCTC and Government of Maharashtra is revised. All remaining terms and conditions of the BGT agreement will be applicable. The detailed notification of the train as issued by GM (Operating) of the concerned Zone shall be shared shortly. Details of Tour Manager & Team on Board on behalf of IRCTC shall be shared beforehand for coordination & smooth conduct of the tour. Special emphasis should be kept on maintaining the Covid Protocols and norms of the local places of visit needs to be adhered.
