Category A: The suppliers empanelled in this Category are eligible for supplying to all IRCTC departmentally operated Static and Mobile Catering units over IRCTC network, except Luxury and Premium Trains like Rajdhani, Shatabdi & Duronto Trains)

Category B: The suppliers empanelled in this Category are eligible to supply their empanelled brand only at a particular Railway stations mentioned in their shortlisting. These suppliers are eligible to supply only to IRCTC departmental static units of IRCTC upto the limit of 10% of the total requirement.. Category B suppliers are not eligible to supply in Mobile operated units.
