- 2. Information desired in all fields are essential, applicants must comply with the corresponding query. If the space provided is not sufficient, then applicant may attach extra sheet(s). Applicants should fill all fields, if the field is not applicable write "Not Applicable".
- 3. All the details must be given along with required supporting documents duly self attested.
- 4. Please enclose attested English translation, by authorized translator, of all documents in regional language.
- 5. IRCTC reserves the right to reject any application at any point of time without assigning any reason.
- 6. IRCTC's decision on empanelment of applicants shall be final and binding.
- 7. The empanelment will normally be valid for one year with provision of further extension, every year depending on the performance of the registered firm.
- 8. IRCTC reserves right to inspect the production facilities, as and when it deems necessary.
- 9. An Earnest Money Deposit (EMD) of Rs 2 lakhs is required to be submitted in the form of demand draft in favour of 'IRCTC' payable at New Delhi along with the application form. Application not accompanied with Earnest Money Deposit (EMD) will be summarily rejected.
- 10. EMD of empanelment of Online Grocery Suppliers will be treated as Standing Earnest Money Deposit (SEMD) and will remain with IRCTC till the validity of the empanelment. SEMD is refundable amount without interest.

 - c. Turnover eligibility criteria

15. General eligibility criteria for empanelment of Online Grocery Chain Suppliers.

- i. Online Grocery stores should have more than five distribution centers(DC) owned /franchisee. Must have presence in not less than 5 Indian cities.
- ii. Online Grocery chain stores should have annual turnover of Rs.25 Crores and above. 50% of the turnover must be from sale of catering items like grocery etc.
- iii. Online Grocery chain stores should have wide branded product range.
- iv. Online Grocery chain stores should have their own system of procurement & distribution of supplies to be delivered through their own/hired vehicle.
- v. Online Grocery chain stores should have strong logistics and supply chain in place.
- vi. Online Grocery chain stores should have computerized billing & accountal system.
- vii. Online Grocery chain stores should possess Registration and other certificates related to retailing as per business norms.
- viii. The Company/ Firm should enclose copy of all relevant documents, in support of requisite information in SRF, along with balance sheet and P&L account of last completed financial years.
