Ref: Your bid submitted against the open E-tender No. 2024/IRCTC/Catg./Refreshment Room/01/Ratlam, NIT dated 13/12/2024.

In reference to the above E-tender submitted for Operation Maintenance and provision of Catering service in / through Refreshment Room (kitchen unit) at Ratlam Railway Station technical bid opened on 06.01.2025 and Financial bid opened on 25.02.2025, this is to inform that the offer submitted by M/s Shri Laxmi Narayan Enterprises has been accepted by the Competent Authority.

- 1) It has been decided to award the License for Operation, Maintenance and Provision of Catering Service in Refreshment Room located at Platform No.04, Ratlam Railway Station to M/s Shri Laxmi Narayan Enterprises for a period of 05 years from date of commencement of operation unless terminated earlier as provided in the Term and conditions of License.
- 2) The approved Annual License Fee is as under.

As per clause no 4.1 of the General Contract Conditions, the quoted License fee for the Refreshment Room awarded to the Licensee shall be payable within 15 days from the date of issuance of LoA.

3) The Security Deposit Amount of Rs. 11,42,678 /- (Rupees Eleven Lakh, Forty Two Thousand, Six Hundred and Seventy Eight) for five years shall be deposited by licensee through NEFT/RTGS OR through unconditional and irrevocable Bank Guarantee (BG) OR Fixed Deposit (FD) (issued by any Nationalized Bank or Scheduled Commercial Bank with validity upto 180 days beyond the completion of the tenure of the contract). The security Deposit shall be refunded without interest on successful completion of the license on submission of claim by the licensee after adjusting the dues / outstanding, if any.

- 4) You are required to convey your acceptance of the Terms and Conditions of the License as per the prescribed format of Acceptance Letter enclosed as **Annexure-"A"** and deposit the Security Deposit within 07 days from issue of this Letter of Award.
- 5) You are also required to execute agreement immediately after commissioning of the unit on judicial stamp paper of Rs 100/- as per Tender Conditions.
- 6) All the Term and Conditions of the tender Document shall remain the same and integral part of this Letter of Award.
- 7) As per clause no. 1.4 of General Conditions of Contract, "The licensee would be allowed 30 days to commission the Refreshment Room from the date of handover of site. However, licensee can seek permission for further 30 days for undertaking any up gradation / renovation / modernization. However, decision of IRCTC will be final in this case.
- 8) The amount should be deposited through Bank Draft/NEFT/RTGS in favour of "IRCTC Ltd" payable at Mumbai.
- 9) A signed copy of tender document should be submitted to IRCTC/West Zone.
