

Sub: Emergency procurement of 20 Litre water Jar at WTC, Nauroji Nagar.

(A) North Zone office was requested to provide 20 Litre water jar at new office in WTC as per existing practice in Statesman House and Punj House. However it has been noticed that there is inadequate supply of water at new office at WTC.

To overcome the shortage of water supply, vendors who are supplying to nearby offices were contacted. M/s Kenzo Nutrico Private Limited who is supplying water at nearby offices has agreed to provide water (20 Ltr Aquafina) @ Rs 70/- (excluding of GST) per bottle as per quotation received from the agency. The agency has also agreed to provide 09 Nos of water dispensers free of cost.


(B) In the year 2014, IRCTC has engaged the Agency for supply of water jars @ 65/- per jar. Therefore the rates offered by the above agency are reasonable.

The total estimated requirement after operation of all the floors is expected to be around 75 water jars (20 litres each) per day. The estimated expenditure per month will be Rs 1,40,000/- (excluding GST).

(2) It is proposed that due to the urgent and essential nature of requirement, the above agency may be awarded the work of supply of 20 Litres water jars @ 70/- per jar, 75 jars per day at WTC initially for the period of 03 months at an estimated expenditure of Rs 4.20 lakhs (excluding GST). In the mean time quotations will be called for selection of agency for water supply.

As per SOP 1.02 (C) under Catering Head, it is within the Competency of GGM to approve the proposal on Nomination basis upto Rs 20 Lakhs.

As per records on file, M/S Beltek Canadian Water Limited (M/S BCWL) has been supplying mineral water jar to IRCTC Corporate Office(s) since 2004, as per the approval of MD and DF vide note dated 20/7/2004 (S.No. 177), M/s BCWL has been approved as supplier for supply of 25 litre jar @ Rs.62/- per jar (i.e. 2.48/litre).

Accordingly M/s BCWL supplied the 25 litre jar of mineral water @ Rs.62/- to IRCTC corporate office at STC, BOB and statesman house.

M/s BCWL vide letter dated 10/9/2012 (SNo. 228) in formed that due to inflation, they has closed 25 liters jar with immediate effect and have introduce 20 liter jar with price of Rs.75/- MRP but for IRCTC, they kept same rate i.e. Rs.62/- w.e.f. 1/10/2012.

However not approval was taken on file regarding change of 25 liter jar to 20 liter jar.

Meanwhile M/s BCWL continued supply of 20 liters jars @ Rs.62/- per jar in absence of any approval on records finance started paying the supplier on prorated basis i.e. 2.48/-per liter and deducted the bills accordingly w.e.f. 08/10/2012.

M/s BCWL vide letter dated 18/11/2013 (SNo.233) represented regarding short payment of Rs. 71647/- along with detail.

The facts regarding supply of mineral water jar by M/s BCWL was put up on file vide pp-117, but no decision was given on the same regarding change of rate and volume.

M/s BCWL vide letter date 17/4/2014 (S No. 249) has represented regarding short payment of Rs.94109/- from Sept.2012 to Jan-2014(SNo. 248). Further the firm has stated that they have increased the rates of 20 liter jar to Rs.65 per jar w.e.f. 01/01/2014 (SNo.250).

In view of the above as the supply of mineral water at corporate office is essential and as such there was no quotations or Tender for supply of Mineral Water Jar since 2004; decision may be taken on the following:

- a) To approve the supply of Mineral water jar of 20 Litre @ Rs. 62/- from M/s BCWL w.e.f. 08.10.2012 till 31.12.2013 and the pending payments may be released accordingly.

Sub.: Supply of Aquafina Brand Mineral Water Jar at IRCTC Corporate Offices.

Ref.: Note on PP-123 to 127.

As per the approval of MD and DF vide note dated 20/7/2004 [S.No.177], M/S Beltek Canadian Water Limited (M/S BCWL) was authorized to supply 25 litre Mineral Water Jar for Rs.62/- per jar to IRCTC w.e.f. 01/08/2004.

In September 2012, M/s BCWL informed that due to inflation Aquafina has stopped 25 litre jar and introduced 20 litre jar with MRP of Rs.75/- but for IRCTC the rates was offered Rs.62/- per 20 litre jar i.e. **Rs.3.1/per litre**. However, no approval was taken on file on the change of volume and rate. Meanwhile M/s BCWL continued supply of 20 ltr Jar for Rs.62/- to IRCTC corporate office at BOB, STC and Statesman House.

In absence of any approval on the changed volume and rate, Finance continued paying the supplier on old approved rates i.e. 62/- per 25 litre jar i.e. **Rs.2.48/- per litre**.

Now, M/s BCWL has Stated that the M/s Aquafina has revised the rates of 20 litre jar to Rs.65/- w.e.f. 01.01.2014, and have claimed an arrear of Rs.93675/- for the short payment.

The matter was put up on file vide PP-123 and it was mentioned that since continuous supply of Mineral Water is essential for supply of drinking water and Tea/Coffee machines for the staff, decision may be given on the following:-

- a) To approve the supply of Mineral water jar of 20 Litre @ Rs. 62/- from M/s BCWL w.e.f. 08.10.2012 till 31.12.2013 and the pending arrear of Rs.93675/- may be released.
- b) To approve the revised rates of Rs. 65/- per jar of 20 litre w.e.f. 01.01.2014 from M/s BCWL till finalization of quotation or tender for supply of Mineral water at IRCTC Corporate Office.
- c) The tender/quotation may be finalized by Procurement department through registered/empanelled suppliers [list placed at SN-251]. There is requirement of 45-50 jar appx. per day at IRCTC Corporate Office[s].

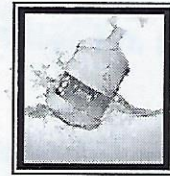


