Subject: RFQ for the Shampooing and Deep Cleaning of curtains and mattress of Golden Chariot train coaches as per Annexure-A enclosed. (Work is to be carried out at Bengaluru).

IRCTC, a Public Sector Undertaking invites quotations for the subject work in **Golden Chariot train** (GC) coaches as per **annexure-A** (including BOQ).

Golden Chariot train, one of the Leading luxury tourist train in the world, consists of 18 coaches, is stationed at Chikballapur, Bengaluru where coaches can be seen by prior intimation to this office. However, work has to be carried out in following 15 coaches in the first phase -

- 11 passenger coaches/Cars, each with four twin bed/double bed cabins
- 2 restaurant coaches.(Ruchi and Nalpaka) with kitchens
- 1 car with bar (Madira).
- 1 coach with spa(Arogya/Gym).

### **Brief Scope of Work**

- The details of the work to be done are given in the BOQ (Annexure-A) which is part of Bid document and rates are to be quoted accordingly.
- The site visit can be arranged on demand to assess the work before providing your quote. The contact person for the site visit shall be Sh. Lokesh (Mobile: +91-8287931958)
- Contractor will make their own arrangement for proper transportation, storage of the material removed from the train stationed at Chikballapur to their own place.
- Curtains and Cot Covers- All the curtains and Cot Covers listed above to be removed
  from the train in Chikballapur Railway station where the train is stationed, the same to be
  transported to your cleaning facility to be stored properly/safely and get it dry cleaned
  and/or laundry cleaned as per fabric type and then to be delivered to the train on
  demand within 2 days from the date of notice. The approximate date of removing the

items shall be immediately after the award of contract ie. By first week of Feb 2020. After completion of the work, the material to be put back at the proper designated place. The approximate date of placing back the items in the train at Chikballapur or any station in Bengaluru area, shall be by 2<sup>nd</sup> week of March 2020.

- Mattress- All the above listed mattress are to be processed with shampooing and deep cleaned at the train in Chikballapur Rly. Station or any Bangalore suburbs wherever the train is stationed, preferably by 1st week of March 2020.
- The items chemical/detergents used for shampooing/cleaning should be appropriately used depending upon the type of material of the upholstery/curtains/mattress are to be restored to mint condition. The odour of the chemical used should be neutralized through appropriate methods. The removed curtains/upholstery/mattress are also to be professionally fixed back after cleaning.
- Surrounding area of the work in coaches/cars such as carpets, flooring, artifacts, and
  fixtures may be covered with tarpaulin/proper masking to avoid any damage or
  defacing of surrounding area during execution of work. The wallpaper area will also be
  covered by polythene before understanding the work in such cabins
- Any removal of furniture, fixture, any electrical or plumbing fittings and artifacts made in the coach to facilitate the work will be on the contractors account and borne by the contractor and after completion of work it will be put in back in the same place and original state.
- The contractor will be responsible for any damage to the items or equipment's of Golden Chariot train (GC) Train or IRCTC which may be caused during the course of work. After completion of work the contractor will ensure cleaning and finishing of the surrounding area & items.

# **Time for Completion**

The time allowed for completion of work will be as per the schedule mentioned above and all the work has to be finished before 10<sup>th</sup> March 2020 or as advised by IRCTC.

## Other Terms and conditions

(a) Eligibility Criteria: The bidder must have completed at least one single similar work of Upholstery cleaning/shampooing work in luxury 3 star hotels and above/Corporate houses/IT companies valuing at least Rs. 1 lakh during the last 2 financial years. Letter of Acceptance/Work order/Certificate of Satisfactory completion of work issued by client to be submitted as proof.

- (b) Inter-se ranking of bids of RFQ will be done on basis of overall lowest value of complete BOQ items. In case of incomplete/conditional quote the bid may be liable for rejection.
- (c) The quoted rates should be exclusive of taxes (GST to be mentioned separately) and required to indicate in corresponding bills also. The bill(s) submitted to IRCTC for payment must include GST No and Bank Details for NEFT/RTGS payment.
- (d) The rate quoted should be for total quantity (the quantity is mentioned in the Annexure) of the respective item. In case the work/rectification is done in less number of quantity/pieces, the payment will be released proportionately.
- (e) In case of variation of the rates in figures and words, the amount mentioned in the words shall be taken as final.
- (f) The work will be carried out in **Golden Chariot'** train (GC) Train stationed at Chikballapur railway station in Bengaluru/or any other sub-urban station in Bengaluru area.
- (g) For the delay of every extra day after schedule time, penalty of Rs. 500 may be imposed.
- (h) Final inspection and acceptance of the work will be carried out by representative of IRCTC. Work quantity may vary. For every unsatisfactory work, the contractor has to recast the work.
- (i) Payment will be released for the actual quantum of work done on Golden Chariot train (GC) by way of NEFT/RTGS after statutory deductions as applicable.
- (j) Final payment shall be made after completion of work duly certified by the authorised representative of IRCTC.
- (k) The rates quoted for the above works/activities should be valid for a period of two month from the date of acceptance of the LOA.
- (l) Statutory deductions as applicable will be made from the bill submitted to IRCTC.
- (m) Bills will be settled by IRCTC within 07 days from the date of submission of such claim and on satisfactory completion.
- (n) Security Deposit: the successful bidder shall submit the SD at 5% of the contract value as per the LOA, within 7 days from the issue of LOA. The SD will be refunded on successful/satisfactory completion of the work.

Sealed quotes may be sent/submitted to the following address on or before 12:00 hrs on 31.01.2020 and quotations will be opened at 12.15 hrs on 31.01.2020. The quotes should be submitted in a sealed cover super scribing "Quotations for Shampooing and Deep Cleaning of Curtains and mattress of Golden Chariot". Any delay in submission of bids on account of postal or any other reasons shall not be accepted
