- 1.2 The information contained in this RFP is being provided by IRCTC for the limited purposes of enabling the Applicants to submit a response to this RFP for undertaking the work and for no other purpose. In no circumstances shall IRCTC, or its respective advisors, consultants, contractors, servants and/or agents incur any liability arising out of or in respect of the issue of this RFP.

2 Invitation for (RFP) Request for Pre-verification

- 2.1 This RFP sets out the requirements that must be satisfied by Applicants in order to participate for tendering for setting up and management of Food Plaza/ Fast Food Unit and is an invitation to applicants to submit their profile/documents for short-listing as Prospective Bidder. The eligibility criteria for RFP are placed at Annexure "A".
- 2.2 IRCTC reserves the right to call for submission of additional documents or any clarification & any other document etc required to be submitted as per RFP.

3.0 Brief introduction to IRCTC



Indian Railway Catering and Tourism Corporation Ltd. (IRCTC) is a Public Sector Enterprise under Ministry of Railways. IRCTC was incorporated on 27th September,

1999 as an extended arm of the Indian Railways to upgrade, professionalize and manage the catering and hospitality services at stations, on trains and other locations and to promote domestic and international tourism through development of budget hotels, special tour packages, information & commercial publicity and global reservation systems.

IRCTC is also managing on Board Catering Services in some Rajdhani / Shatabdi /Duronto/Mail Express Trains and Static Catering Units such as Food Plazas, Fast Food units across at Railway stations. IRCTC also has its business presence in Non-Railway Catering at various Govt and private institutions.

4.0 Organization structure

Corporate Office of IRCTC is situated at New Delhi, which is headed by the Chairman & Managing Director. Chairman & Managing Director is assisted by three Directors, Director (Catering Services), Director (Tourism & Marketing) and Director (Finance) and Group General Managers.

For smooth operations of the business across all over the country, five Zonal Offices are working at Delhi, Kolkata, Mumbai, Chennai and Secunderabad. South Zone & West Zone Offices are headed by Regional Director and all other Zonal Offices are headed by Group General Managers. All Group General Managers have vast experience of working in Indian Railways. These Zonal Offices are assisted by ten Regional Offices at Lucknow, Chandigarh, Jaipur, Bhubaneswar, Guwahati, Patna, Bhopal, Ahmedabad, Bangalore and Ernakulum, which are headed by Chief Regional Managers / Regional Managers.

5.0 Scope of Food Plazas and Fast Food Units

5.1 Food Plazas are normally set up to provide multi-cuisine variety of food under one roof in a relaxed atmosphere with good ambience. It has common kitchen to provide variety of food items.

Fast Food Unit is the term given to food that can be prepared and served very quickly. While any meal with low preparation time can be considered to be fast food, typically the term refers to food sold in a restaurant or store with preheated or precooked ingredients, and served to the customer in a packaged form for take-out/take-away with minimum cooking facility.

- **5.2** As per mandate of Catering Policy the Food Plaza and Fast Food Units are awarded through open tender under two packet tender system consisting Technical Bid (Pkt A) and Financial Bid (B). The applicants who qualify in technical bid (Pkt A) become eligible for opening of Financial Bid (Pkt B). License of FP/FFU is awarded to the highest bidder.
- **5.3** As per Catering Policy 2017, Food Plaza is awarded for a period of nine years without any further extension. Fast Food Unit is awarded for a period of five years with no extension.
- **5.4** The Food Plaza will have three kinds of format i.e. Type A, Type B & Type C


- **5.4.1. Type A:** will be a Standard FP format for the places which do not have high footfall, less popular stations or smaller A category stations in terms of catering.
- **5.4.2. Type B:** will be of Branded FP will be operated by A renowned national or multinational brand having outlets in at-least 4 cities out of Delhi, Mumbai, Kolkata, Chennai, Ahmadabad, Pune, Hyderabad, Bangalore outside Railway premises. These will be taken up on selected A1 and A category stations. Documents such as FSSAI licenses of units in Metro Cities, Lease/ Purchase agreements etc. to be submitted.
- **5.4.3 Type C:** Multi Cuisine and Multi-Operators at selective stations the Food Plaza operator will have a local F&B Outlet or a branded player as defined above in addition to its own brand. Hence there will be a minimum of two brands functional which will operate like a food court with common sitting area.

6.0 RFP Security

- 6.1 Each applicant shall, simultaneous with submission of its profile/documents as part of its Eligibility criteria, furnish the RFP Security (refundable) an amount of Rs. 1,00,000/- (Rupees One Lakh only) in the form of a demand draft. The demand draft shall be drawn in favour of 'Indian Railways Catering and Tourism Corporation Limited (IRCTC), payable at the city where RFP is being submitted, issued by a Nationalized/ Scheduled Bank. However, at the time of tendering, the shortlisted applicant has to also submit EMD amount as prescribed in the tender document.
- 6.2 It may be noted that above RFP Security is not SEMD, therefore the bidder has to submit EMD & Security Deposit along with tender document as per the applicability defined in the Tender Document.
- 6.3 It is clarified that IRCTC shall not be liable to pay any interest on the RFP Security so submitted by the applicant.
- Any application not accompanied by the RFP Security shall be rejected by IRCTC as non-responsive and will be summarily rejected.
- 6.5 The RFP Security shall be refunded without interest to the applicants whose applications are rejected for empanelment.
- 6.6 For the applicants who are shortlisted through this RFP process, the RFP Security shall be retained & shall be refunded without interest only after successful completion of the tenure of the short-listing.

7.0 Tenure of Short-listing

- **7.1** The period of the short-listing shall be 03 years & may be extended at the discretion of IRCTC.
- 7.2 IRCTC reserves the right to review the performance of shortlisted applicant and to take suitable action on observing default/deficiency/ misleading in service, documents etc. including but not limited to imposing fine or cancelling of short



listing the applicant with consequential debarment from the future projects/tenders of IRCTC for a period for 1 year.

7.3 The shortlisted applicant may withdraw its short-listing after submitting a written request only after completion of three years. Subsequently the RFP Security will be refunded without any interest.

8.0 General Conditions:

IRCTC reserves the right to terminate the RFP process at any stage and will not be responsible for any loss or damages which the applicant may incur in the process. The application can be rejected without assigning any reason. Conditional / telegraphic application shall not be entertained. All the pages of the RFP document, duly stamped and signed by the bidder(s) should be submitted in original, unless specified otherwise, in their respective envelops.

- **8.1** In order to widen participation base the Short-listing has been resorted to ensure inclusion of new prospective bidder, the RFP, will be **open throughout the year** and can be submitted on any of working day.
- **8.2** In case the applicant suffers any loss on account of his being restrained by the IRCTC or any competent authority for indulging in illegal activities or any contravention of any law or rejection of application for short listing through this RFP process, it shall not be entitled to any compensation whatsoever.
- **8.3** In the event of any breach of the said terms and conditions of the short-listing, IRCTC shall be entitled to forfeit the RFP Security besides cancelling short-listing and debarring the Prospective bidder from participating in the future projects of IRCTC for a period of 1 year.
- **8.4** The Short shortlisted applicant shall comply with any other instructions issued by IRCTC from time to time within a reasonable time, as may be felt necessary. IRCTC may conduct inspection of the unit and the short-listing shall also depend on the condition that the unit should match the standards for supply of meals to passengers. In case, the unit is not found suitable for supply of meal then, the shortlisted applicant shall have to improve and make up the deficiency as stipulated standard by IRCTC.

The shortlisted applicant and/or its F&B operator should have GST registration for the location for which he is submitting the application as the present taxation structure w.e.f 01-July17 GST has been made mandatory by Govt. of India.

- **8.5** No exclusive rights to be provided to any Shortlisted applicant for a specific Train /station/section/state. They are required to work in the current environment.
- **8.6** The shortlisted applicant shall be solely responsible for lapses, violation and non-compliance, if any of all statutory dues etc.
- **8.7** The shortlisted applicant deemed to be for all legal and contractual purposes, as the employer of the staff employed by him/her or his authorized operator for carrying out this contract will not have any claim for employment in IRCTC at a future date.



- **8.8** Applicants/Parties shortlisted under this provision for FP/FFU on A1&A Category of stations shall also be implied to be qualified for participating in tenders of FP/FFU invited by Zones for B,C, D & E category of stations over Indian Railways.
- **9.0** IRCTC, without being under any obligation to do so, reserves the right to call for any clarifications during the process of checking of responsiveness of a application and to reject any application which is non-responsive. However, no Bidder shall have the right to give any clarification unless asked for by IRCTC or to request either IRCTC and/or any ministry or department, authority or body whether statutory or non-statutory, of the Government that may be concerned or connected, in any manner whatsoever, with this Short-listing Process, to intervene in, any manner whatsoever, in the Short-listing Process.
- 10.0 Notwithstanding anything to the contrary contained in this RFP, IRCTC may, at its sole discretion, waive any minor infirmity, non-conformity or irregularity in a application that does not constitute a material deviation, and that does not prejudice or affect the relative position of any applicant, provided it conforms to all the terms, conditions of the Short-listing documents without any material deviations, objections, conditionality or reservations. A material deviation, objection, conditionality or reservation is one (i) that affects, in any substantial way, the scope, quality or performance of the contract; (ii) that limits, in any substantial way, inconsistent with the Short-listing documents, IRCTC's rights or the Successful applicant obligations under the contract; or (iii) whose rectification would unfairly affect the competitive position of other Applicants, who are presenting responsive application.
- **11.0** This is request for pre-verification of document only to enable the participant to guide about the document required for submission of tender for FP/FFU and shall not be treated as submission of tender document.




