# General instructions to Applicants

- 1. All documents submitted along with the 'EOI' application should be serially numbered on the top right hand corner of every page of the EOI Document.
- 2. The requisite instrument of EOI SEMD (Standing Earnest Money Deposit) should be attached with page number one, as mentioned above, of the EOI Document.
- 3. The name of the applicant should be mentioned on the reverse of the respective DD, attached as EOI SEMD with the EOI application.
- 4. Applicants who have downloaded the EOI document from the IRCTC's website must submit the EOI SEMD along with the application.
- 5. This EOI document should be duly signed and stamped by the authorized signatory of the applicant. Board Resolution for authorization to authorized signatory should be enclosed.
- 6. The EOI document should be submitted in original with all pages intact.
- 7. Eligibility bid should be submitted in a sealed envelope clearly indicating applicant's name and address and the date of opening the EOI. The validity of application shall be for 120 days from the date of submission of application.
- 8. In support of Two (02) years experience, attested copy of authentic documents currently valid, clearly proving applicant's existence in catering / hospitality business, involving production and Sale/Service/Supply of cooked food items since at least Two (02) years, **such as (one of the following):**
  - i) Award of currently valid license in favor of applicant by Railways/IRCTC or by any Statutory/Private or Public organization, dating more than Two (02) years.
  - ii) Currently valid Food license (FSSAI) of the operational unit dating more than Two (02) years.
  - iii) State/ Central Government currently valid document indicating presence in catering/hospitality business dating more than Two (02) years.
  - AND in support of the business, furnish ALL the currently valid following documents:
    - i) Income Tax returns of last completed Two (02) Financial Years.
    - ii) Currently valid GST registration no.
    - iii) VAT OR Service tax registration certificates dating more than Two (02) years.
    - iv) Currently valid EPF Registration
    - v) Currently valid ESI Registration.

- 1.1 This Expression of Interest ("EOI") is being issued by the Indian Railway Catering and Tourism Corporation Limited ("IRCTC") for the purpose of providing certain information to the Applicants to participate in the Process for empanelment of qualified applicants for the purposes of provision of catering services through award of temporary license for operation and management of Jan Ahar, Refreshment Room, Cell Kitchen & Base Kitchen, on a short term basis, at various stations over Indian Railways network.
- **1.2** The information contained in this EOI document is being provided by IRCTC for the limited purposes of enabling the applicants to submit a response to this EOI for undertaking the work and for no other purpose. In no circumstances shall IRCTC, or its respective advisors, consultants, contractors, servants and/or agents incur any liability arising out of or in respect of the issue of this EOI.
- **1.3** The information contained in this EOI or subsequently provided to applicant(s), whether verbally or in documentary or any other form, by or on behalf of the IRCTC or any of its employees or advisors, is provided to applicant(s) on the terms and conditions set out in this EOI and such other terms and conditions subject to which such information is provided.
- **1.4** This EOI is not an agreement or offer by the IRCTC to prospective applicants or any other person. - 2.0 This EOI sets out the requirements that must be satisfied by applicants for getting empanelled as service provider in order to participate in the process for award of temporary license for operation and management of Jan Ahar, Refreshment Room, Cell Kitchen & Base Kitchen, on a short term basis, at various stations over Indian Railways network and it is an invitation to applicants to submit their profile/documents for empanelment as Service Provider.
- 2.1 The EOI document shall be issued by IRCTC upon receipt of payment of a non-refundable fee of Rs. 1050/- ("Processing Fee") through a demand draft in favour of Indian Railway Catering and Tourism Corporation Limited, payable at **Kolkata**.

Alternatively, applicants may also download the EOI document from the IRCTC's website (http://www.irctc.com). In such event applicants shall submit **Rs. 1050/- ("Processing Fee")** through a demand draft issued by scheduled commercial banks in favour of Indian Railway Catering and Tourism Corporation Limited, payable at **Kolkata** along with the EOI application.

**2.2** Applications unaccompanied by either of the Processing Fee or a receipt evidencing submission of the Processing Fee shall not be considered.



#### 3.0 Schedule of Process

**3.1** The important dates in respect of the process for empanelment have been mentioned below: IRCTC reserves the right to amend by extending the stipulated dates for commencement of sale of EOI document, meeting & submission of EOI document without incurring any liability whatsoever. In the event of changes/extension/preponement, IRCTC shall intimate the same through addendums/amendments. IRCTC also reserves the right to cancel or discharge the EOI process without assigning any reason.

**3.2** The applicants may apply for empanelment as per the eligibility defined in the document.

Upon empanelment, party may participate in the bidding process invited by IRCTC for award of temporary license for management of Jan Ahar, Refreshment Room, Cell Kitchen & Base Kitchen, on a short term basis, at various stations over Indian Railways network from time to time as per the laid down criteria.

## 3.3 Eligibility Criteria

3.3.1 Eligibility criteria for empanelment is defined in clause 9.0 of this EOI document. Interested organizations should submit documentary evidence in support of the eligibility criteria.

#### 4.0 Background of the work

- Refreshment Rooms, Jan Ahars, Cell Kitchens & Base Kitchens have been set up by Indian Railways over various stations for provision of meals and other food & beverages to passengers traveling over Railways.
- Ministry of Railways has issued Catering Policy 2017 wherein IRCTC has been mandated to manage Refreshment Room located at category 'A1' & 'A' class stations, Jan Ahars, Cell Kitchens & Base Kitchens. IRCTC is under the process of takeover and shall award temporary license in order to operate and manage such units, as per requirement, through tendering process.



- The units are located at stations and may or may not be air conditioned. The seating capacity of Refreshment Rooms, Jan Ahars, Cell Kitchens may vary from location to location. The internal infrastructure may also vary at different stations.
- There may be more than One (01) refreshment room at any given station. The refreshment room could be Vegetarian, Non-vegetarian or both at one location.
- Generally, only single unit of Jan Ahar, Cell Kitchen and Base Kitchen are located at station.
- Non-veg and Veg meals are to be prepared separately at the earmarked locations/sections in the kitchen.
- Meal items along with other food & beverage items may be sold from Refreshment Room located at category 'A1' & 'A' class stations, Jan Ahars, Cell Kitchens.
- Meals are only prepared and packaged at Base Kitchens for supply to mobile and other units for sale/service. Meals are not sold from Base Kitchens.
- The units may either be well equipped or may have partially or not equipped as per case to case basis.
- The menu and food items to be served are as per the IRCTC/Railway approved standard meal items, a-la-carte meal items, shortlisted and approved PAD items, Railneer etc. The menu may be revised from time to time.
- The units are to be operated as per the advice of IRCTC. Operational timings of the units are as per the advice of IRCTC.

# 5.0 Role of IRCTC and the Service Provider

# 5.0 Role of IRCTC

- IRCTC will empanel the service providers among the applicants who will be eligible to participate in the bidding process for provision of catering services from Refreshment Rooms, Jan Ahars, Cell Kitchens & Base Kitchens at various stations over Indian Railway network on temporary basis as an adhoc arrangement.
- IRCTC will invite financial Bids from empanelled service providers.
- Normally, Bidders will be given 14 days to participate in the bidding process for calling bids. However, in exceptional cases Service Providers will be required to make catering arrangements within this period which may, in some cases, be as low as 2-3 days for provision of catering services.
- Bid Document containing terms and conditions of license including the Scope of Work, menu & rates, details of unit, station, infrastructure, terms & conditioned of license, financial bid etc. will be sent through e-mail and courier/speed post at the given address/details as provided by the applicant.



## 5.1 Role of the Service Provider

- Service Provider will submit financial bid as prescribed in the bid document at the venue, date and time as mentioned in the bid document.
- No bid shall be accepted through email.
- After receipt of Letter of Award for provision of catering services in Refreshment Rooms, Jan Ahars, Cell Kitchens & Base Kitchens, as the case may be, the service provider will mobilize his resources required for the requisite services.
- The provision of services shall start from the date mentioned in the letter of award, in accordance with the schedule.
- The Service provider is expected to provide good quality and hygienically prepared food to passengers as well as supply to trains as per advice of IRCTC. He will deploy trained manpower for provision of catering services.

#### 6.0 EOI SEMD

- 6.0 Each applicant shall, simultaneous with submission of its profile/documents as part of its Eligibility criterion, furnish the SEMD (refundable) for an amount of **Rs. 1,00,000/- (Rupees One Lakhs only)** in the form of a demand draft. The demand draft shall be drawn in favour of 'Indian Railways Catering and Tourism Corporation Limited (IRCTC Ltd.), payable at **Kolkata**.
- **6.1** It is clarified that IRCTC shall not be liable to pay any interest on the EOI SEMD so deposited by the applicant.
- 6.2 Any application not accompanied by the EOI SEMD shall be treated as non-responsive and shall not be considered by IRCTC.
- **6.3** The SEMD shall be refunded to the applicants whose applications are rejected for empanelment.
- 6.4 For the applicants who are empanelled as Service Providers through this EOI process, the EOI SEMD shall be retained & shall be refunded without interest only after successful completion of the tenure of the empanelment.
- 6.5 SEMD will not be adjusted against the Security Deposit of individual licence.
- **6.6** IRCTC reserve the right to recover any outstanding dues from the successful applicant post empanelment by adjusting the same against the SEMD.



## 7.0 **Period of Empanelment**

7.0 The period of the empanelment will up to **30.09.2019**. However, IRCTC reserves the right to review the performance of empanelled party and to take suitable action on observing default/deficiency in service etc. and non-participation in the quotation process including but not limited to imposing fine or de-empanelment of the party with consequential debarment from the future projects/tenders of IRCTC for a period for 1 year and forfeiture of SEMD.

#### 8.0 General Conditions

- **8.0** IRCTC reserves the right to terminate the EOI process at any stage and will not be responsible for any loss or damages which the applicant may incur in the process. The application can be rejected without assigning any reason
- **8.1** Conditional/ telegraphic application shall not be entertained. All the pages of the EOI document, duly stamped and signed by the bidder(s) should be submitted in original, unless specified otherwise, in their respective envelops.
- **8.2** Applications received after stipulated date & time for submission of EOI applications will not be entertained.
- **8.3** No over writing/cutting/insertion in the EOI application document is allowed. The Application once submitted would be binding on the Party and any subsequent alteration/amendment will not be entertained.
- 8.4 All the pages of the EOI application document must be signed and stamped by the authorized signatory of the applicant, failing which the application will be treated as invalid
- 8.5 Applicant will be responsible for compliance with applicable laws such as VAT Law, Service Tax Law, Provident Fund Law, Labour Law or any other law of the land and registration/approval from statutory authority, if required
- **8.6** In case the applicant suffers any loss on account of his being restrained by the IRCTC or any competent authority for indulging in illegal activities or any contravention of any law or rejection of application for empanelment through this EOI process, he shall not be entitled to any compensation whatsoever.



- 8.7 All questions, disputes and or differences arising under or in connection with this EOI or in touching or relating to or concerning the construction, or affect of presents shall be referred to the sole arbitration of the officer/officers or persons nominated by the Chairman and Managing Director/IRCTC whose decision in this regard shall be binding on the applicant. The venue of the arbitration shall be New Delhi. The Fee & expenses of the arbitration Tribunal shall be shared jointly in equal proportion by the parties.
- **8.8** In the event of any breach of the said terms and conditions of the empanelment, IRCTC shall be entitled to forfeit the SEMD besides deempanelling and debarring the service provider from participating in the future projects of IRCTC for a period of 1 year.
- **8.9** IRCTC at their discretion may call for any record to satisfy them regarding operations of the applicant's outlets and applicant will provide every help failing which it may amount to breach of condition of the empanelment.
