(iv) Certificate from CA that the audited/provisional for 2017-18 turnover figures are reconciled as per VAT/Service Tax/GST returns in the format at Annexure 1B

“The applicant shall also submit an affidavit stating that the turnover shown in GSTR3B is from Catering and Hospitality business.”

Incase Balance Sheet and Profit and loss account of 2017-18 is not audited by statutory auditor yet, provisional balance sheet and provisional profit and loss account has to be submitted. Final figure may be submitted after audit. If in the final figures it is found that bidder is not fulfilling the eligibility criteria, License even if awarded will be cancelled and security deposit and license fee deposited will be forfeited.
