With reference to the subject mentioned above, it has been decided to award to you license for provision of onboard catering services in mail express/rajdhani/shatabdi / duronto and other pre/post-paid trains in partial / complete unbundling model (composite model) on Concession fee mentioned below & applicable taxes, in addition to 15% license fee plus applicable taxes deductible from running catering bill for train no. **12213-14, YPR-DEE Durgam Express** and on License fee mentioned below plus applicable taxes for train no. **22677-78, YPR-KCVL AC Express** for a period of 03 months or finalization & commencement of long term tenders whichever is earlier or takeover of services by new Licensee/Railways/IRCTC, whichever is earlier, purely on adhoc basis subject to the terms and conditions enshrined in the tender document, which shall form part of the License.
