With reference to the subject mentioned above, it has been decided to award to you license for provision of onboard catering services in mail express/rajdhani/shatabdi / duronto and other pre/post-paid trains in partial / complete unbundling model (composite model) on Concession fee mentioned below & applicable taxes, in addition to 15% license fee plus applicable taxes deductible from running catering bill for train no. 12293-94, LTT-PRYJ Duronto Express and on License fee mentioned below plus applicable taxes for train no. 22115-16, LTT-KRMI AC Exp for a period of 03 months or finalization & commencement of long term tenders whichever is earlier or takeover of services by new Licensee/Railways/IRCTC, whichever is earlier, purely on adhoc basis subject to the terms and conditions enshrined in the tender document, which shall form part of the License. The above award of temporary license is subject to the terms and conditions of tender document and Government of India directive to contain COVID.

C) First day of start of catering services in the train will be treated as date of commencement of Onboard Catering Services.

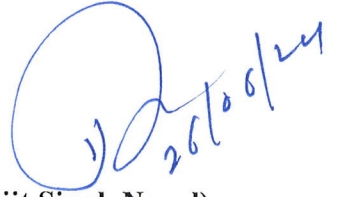
