ADDENDUM NO. 1 to LETTER OF AWARD (LOA) dated 08.03.2024

Sub: Acceptance of the Offer for Award of License for Commissioning and Operation of Base Kitchens at locations pre-notified in the tender document along with provision of On-board Catering Services in all trains of cluster no. EZ/ER/CLT-B-5 for a period of 05 years, further extendable upto 02 years.

- Ref: 1) Open E-tender no. 2024/IRCTC/P & T/CLUSTER/FEB/ EZ/ER/CLT-B-5 opened on 01.03.2024.
 - 2) LOA issued vide letter no. 2024/IRCTC/P AND T/CLUSTER/FEB/EZ/ER/CLT-B-5 dt. 08.03.2024.
 - 3) Your office letter no. nil dt. 20.08.2024 & 09.08.2024.
 - 4) Eastern Railway Notification dated 21.02.2024.

Vide letter referred at (2), contract of cluster no. ER/CLT/B-5 was awarded to your firm for 05+02 years. As per the contract, frequency of train no. 12336-35 LTT-BGP-LTT was triweekly. However, vide letter referred at (4), train no. 12336-35 LTT-BGP-LTT which was running tri-weekly has been reduced to bi-weekly with addition of integrated rake with train no. 22311-12 LTT-Godda-LTT which will run weekly.

Vide letter referred at (3), you had requested this office to include train no. 22311-12 LTT-Godda-LTT in contract of cluster no. ER/CLT/B-5.

As per clause 3.4 of tender doc- Management of Onboard Catering Services in trains to be introduced with integrated / lie over rake of Master License Agreement states that "On introduction of new train with the lie over rake of the existing train the licensee shall manage the OBCS by the new train on payment of additional proportionate license fee for that particular train which shall be in the same ratio of QLF:MLF of that train."

Also, as per clause 2 of FINANCIAL TERMS AND CONDITIONS states that-Licensee fee for the entire cluster shall be paid on an annual basis in advance. There shall be no provision for deduction of license fee from the catering bills of pre-paid trains. There shall be no revision in the license fee during the currency of contract due to revision in menu and/or tariff. However, due to any increase/decrease in the scope of work/business such as
