Indian Railway Catering and Tourism Corporation Ltd. (IRCTC) is a "Mini Ratna (Category-I)" Central Public Sector Enterprise under Ministry of Railways, Government of India. IRCTC was incorporated on 27<sup>th</sup> September, 1999 as an extended arm of the Indian Railways to upgrade, professionalize and manage the catering and hospitality services at stations, on trains and other locations and to promote domestic and international tourism through development of budget hotels, special tour packages, information & commercial publicity and global reservation systems.

- IRCTC requires experienced and result oriented retired employees for need-based engagement in Office at East Zone/Guwahati & Patna Regional Offices on re-engagement basis for a total vacancy of 2 (number of vacancy). To meet the immediate requirement of manpower, the Company invites applications from Retired Officials, only from the Operating /Traffic department of Indian Railways viz Station Masters, Traffic Inspectors, Controllers, Chief Yard **Masters**, etc. to form need based panel through selection procedure.
- The deployment of the selected retired employees through the said selection procedure will be made as per administrative requirement/need basis for posting in IRCTC in its various offices. The empanelment of Retired employees will be as per the eligibility criteria laid down in HR policy and as revised/amended from time to time, based on the Level/pay-scale (7th CPC/3rd PRC) from which the employee has retired. - 4. Further details are as under:
  - I. Age: As per HR policy, the re-employed employees will be allowed to work up to the maximum age limit of 65 years. On the date of issue of notification, the age of retired employee should not exceed 64 years of age.
  - II. Duration: The selected candidates will be placed on the panel and will be reemployed/deployed based on requirement, initially for a period of one year, which can be extended as per the requirements/performance of the retired employee and at the sole discretion of company i.e. IRCTC. The re-employment can be terminated pre-maturely on one month's notice by either side.
  - III. Remuneration: A fixed monthly amount shall be admissible, arrived at by deducting the basic pension from the pay drawn at the time of retirement. The amount of remuneration so fixed shall remain unchanged for the term of the contract. Entitlement for Conveyance allowance and Mobile charges will be governed as per IRCTC's policy. No other allowance is admissible. In case of tour on duty, TA/DA/lodging charges admissibility will be as per rates defined for equivalent scales in IRCTC as IRCTC's policy.
