- 4) To submit preliminary plans, specifications and tentative time schedule for commissioning of above unit for approval of IRCTC with Zonal/Regional office under East Zone within fifteen (15) days from the date of remittance of security deposit.
- 5) If Railway/IRCTC suggests changes in the General Arrangement of Drawing (GAD), the new GAD has to be submitted within fifteen (15) days after advice by zonal office.
- 6) You required to pay advance annual license fee and GST thereon along with land license fee with applicable taxes and other taxes if any to IRCTC in advance.
- 7) You are required to pay License fee as mentioned in the point no. 3 above, GST thereon and other tax if any to IRCTC. The quoted annual License Fee for 1st year shall be paid in advance at the time of handing over of site but is applicable from time of commissioning of Executive Lounge or within 120 days from the date of issue of LOA whichever is earlier.
- 8) You are required to take over the site within time frame specified by IRCTC Zonal / Regional office after issuance of letter of approval of GAD. At the same time you are also required to deposit Annual License Fee (plus all applicable taxes) agreed upon.
- 9) License fee will be increased by 7% per year compounded annually from second year onwards. At the start of second year the license fee deposited will be 7% more than the quoted license fee for first year or 15% of the annual sales turnover for the first year, whichever is higher. Similar increase in payments of license fee will be followed for each subsequent year of service.
