After Completion of Journey originating IRCTC Zonal office will claim License fee @ plus applicable GST over the total sales.

(C) IRCTC shall make necessary statutory deductions of tax at source and any other deduction in respect of onboard catering services.

(D) Provision for sale of Packed items (PAD items) like Biscuits, Namkeen, Chips, Aerated Drinks, Fruit Drinks, Juice, Packaged Drinking Water etc from Military Langer only (no vending inside the coaches).

(E) You are required to start the provision of catering services as per advise of IRCTC.



- (H) Supply/sale of Railneer is to be made in the train in terms of clause no. 2.9, 2.10 & 2.11 of Scope of Work of the tender condition.
- (I) At least (One) 01 no. of Hand held billing machines should be made available in the train for generation of e-bills and receipt of payment for PAD/Tea, coffee/PDW sale. No onboard sale to be made without issuance of e-bills.
- (J) Violation of guidelines/directives issued by Government of India, MHA and IRCTC with regard to COVID-19, shall attract penalty provisions which may extend upto termination of contract.
- (K) Award of license shall be subject to the final outcome of litigation, if any, pending adjudication before any Court/tribunal of Competent jurisdiction
- (L) The terms & Condition of bid document shall form an integral part of this letter of Award.
