- F) Supply/sale of Railneer is to be made in the train in terms of clause no. 2.11, 2.12 &2.13 of Scope of Work of the tender condition on MRP.
- G) Point of Sale machines as per clause 2.18 of tender document has to be ensured.
- H) IRCTC approved, Packed branded RTE items like poha, Upma, Veg meal, Combo meal etc. with FSSAI license and MRP, with best before date has to made available in train in addition to Cooked Food.
- Strict compliance of guidelines issued by Government of India, MHA and this office for COVID-19, in this regard, should be followed and any violation thereof shall invoke penalty which may extend upto termination of contract.
