




- (C) Bills shall be submitted in concerned zonal office. Payment for on-board catering services shall be done by concerned IRCTC Zonal office to the Service Provider on the basis of the actual number of passengers served over the entire journey. The Service Provider shall submit bills for onboard delivery within 07 working days of completion of round trip along with certificates of Tour Manager cum guide for bills to be entertained.
- (D) Payment to service provider shall be made after retaining the GST composition of the above collection which is payable to GST authority to ensure statutory compliance, if any.
- (E) IRCTC shall make necessary statutory deductions of tax at source and any other deduction in respect of onboard catering services.
- (F) No payment will be made for second helping.
- (G) Service Provider will be paid 80% of the total amount due, within 07 working days of bill submission along with occupancy certificate issued by onboard Tour Manager cum guide post completion of round trip and remaining 20% shall be paid within 15 working days from the date of submission of Bills.
- (H) You are required to start the provision of catering services as per advise of IRCTC.
- (J) Before commencement of services, details of en-route FSSAI certified kitchen are required to be submitted to concerned Zones in enclosed format for acceptance letter.
- (K) Failure to accept Letter of award(LOA) of License or failure to submit Security Deposit within stipulated time, as advised by IRCTC shall empower IRCTC to initiate action as contemplated under Tender Document.
- (L) Supply/sale of Railneer is to be made in the train in terms of clause no. 2.9,2.10 & 2.11 of Scope of Work of the tender condition.

- (M) At least (One) 01 no. of Hand held billing machines should be made available in the train for generation of e-bills and receipt of payment for PAD/Tea, coffee/PDW sale. No onboard sale to be made without issuance of e-bills.
- (N) Violation of guidelines/directives issued by Government of India, MHA and IRCTC with regard to COVID-19, shall attract penalty provisions which may extend upto termination of contract.
- (O) Award of license shall be subject to the final outcome of litigation, if any, pending adjudication before any Court/tribunal of Competent jurisdiction
- (P) The terms & Condition of bid document shall form an integral part of this letter of Award.
