Part (A): Commissioning of Base Kitchens at all pre-notified locations of the cluster.

- i. Acceptance of Letter of Award (LOA) is to be submitted within 15 days from the date of issue of LOA during which completion of all commercial formalities submission of SD as mentioned above BG/FDR/NEFT/RTGS), which is 10% of the quoted License Fee for the entire (in the Cluster for entire duration, submission of Advance Annual License Fee and signing of agreement for Part A shall be completed. License Fee for the entire cluster shall be paid in advance on an annual basis. However, the License Fee for trains which will be handed over in future i.e. after completion of existing running contract will be required to deposit annual License Fee in advance, 30 days before the handing over of that/those trains of the cluster, unless stated
- ii. Setup and commissioning of Base Kitchen at designated locations shall be mandatory within the stipulated timelines. Scope of work for Part-A shall include identification/leasing/renting of land/building/space, completion of civil works, furnishing and providing and fixing of equipment as per defined specifications of IRCTC, staff deployment and procurement system in place and issue of commissioning certificate jointly by IRCTC, Railway & Your firm. IRCTC will deploy its staff for supervision.
