i. Acceptance of Letter of Award (LOA) is to be submitted within 15 days from the date of issue of LOA during which completion of all commercial formalities i.e. submission of SD as mentioned above (in the form of BG/FDR/NEFT/RTGS), which is 10% of the quoted License Fee for the entire Cluster for entire duration, submission of Advance Annual License Fee and signing of agreement for Part A shall be completed.
