I, Naresh Kumar Sinha, Practicing Company Secretary and proprietor of Kumar Naresh Sinha & Associates, Company Secretaries, have been appointed as the Scrutinizer pursuant to the provisions of Section 108 and 110 and other applicable provisions, if any of the Companies Act, 2013 ("the Act") read with Rule 20 & 22 of the Companies (Management and Administration) Rules, 2014 and Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("the Listing regulations"), to scrutinize the remote electronic voting process of Postal ballot of Indian Railway Catering and Tourism Corporation Limited (IRCTC), held between Saturday 12th March, 2022 (09:00 Hours) and Sunday 10th April, 2022 (17:00 Hours) IST.

The Shareholders of the Company holding shares as on the "cut-off" date i.e., Friday 04th March 2022, were entitled to vote on the resolution(s) as set out in the Notice of the Postal ballot of Indian Railway Catering and Tourism Corporation Limited (IRCTC).

The voting period for remote e-voting commenced on Saturday 12th March 2022 (09:00 Sinha Hours) and ended on Sunday 10th April 2022 (17:00 Hours) IST and thereafter the CDSL_{S-180}
