Sub:- Registration of Udyog Aadhar Memorandum (UAM) by Ministry of Micro, Small and Medium Enterprises (MSME) vendor on central Public Procurement Portal (CPPP)-reg.

Ref:- Office of the Developmental Commissioner letter no. 21(17)/2016-MA dated 06.04.2018 (copy Enclosed).

In reference to above subject, guidelines was issued by the Office of Developmental Commissioner (letter Attached), in this letter that "*declaration of UAM number by vendors on CPPP is mandatory from 01.04.2018 and it is requested to all procuring entities to ensure that their tender documents containing a condition regarding declaration of UAM number by MSE bidders on CPPP, falling which such bidders will not be able to enjoy the benefits*". These guidelines are also the part of Tender documents of IRCTC.

It has been now decided not to include above clause in any tender documents of IRCTC till further order.


